#### A MESSAGE FROM OUR EXECUTIVE DIRECTOR Politics as usual??!

Hello friends,

Governor Tony Evers actively supports the LGTQ+ community, communities of color, and youth. Other states are not as fortunate. It's hard to keep up with the hateful legislation being introduced, but we recommend that you regularly check and share this website <u>translegislation.com</u>, and others like it.

Last year <u>174 anti-lgbtq+ bills were introduced</u>. So far this year, <u>353 have been introduced</u>. Sit on that for a second. It's February 16th.

In Wisconsin, we have WI SB4 which suspended the rule that prevented therapists and counselors from trying to change youth's sexual orientation or gender identity. Also known as conversion therapy. This bill has not passed. If it does, it could make conversion therapy an acceptable practice again. The American Psychological Association has been opposed to conversion therapy for years.

Recently in South Dakota, a bill was passed to prevent doctors from administering hormones, puberty blockers, or surgery to youth. We heard from LGBTQ+ organizations in the state who say some youth will have to flee to other states to find the services they need.

In other news...Oklahoma has a bill saying that if a physician or other healthcare professional is found to have knowingly referred a patient or provided gender transition procedures to an individual under twenty-six (26) years of age...they will lose their license to practice.

In Arizona...a bill was introduced saying a drag performance will be reclassified as someone who exhibits a gender identity that is different from the performer's gender assigned at birth...Sings, lip-synchs, dances, or otherwise performs before an audience of at least two (2) persons for entertainment, whether performed for payment or not; ...will require the venue to be reclassified as an adult-oriented venue.

Most of these bills will not pass despite conservative majorities in the states, but many will pass. The hate has been fueled. The political agenda is clear. It's

time to make your opinions heard. You can <u>contact our state assembly leaders</u> and <u>state senators</u>.

Watch this space.


#### LOOKING AHEAD Youth Equality Prom 2023 Save the date

Meet Dr. Steven Wipijewski

I am a family medicine physician and have recently begun accepting patients at Aurora Healthcare in Racine. I completed my residency training at Aurora St. Luke's in Milwaukee, and took a primary care position out of residency to work for Fenway Health in Boston, MA providing care for the HIV+ and LGBTQ+ communities.

I provide gender-affirming care to patients with various gender identities, PrEP, PEP (postexposure prophylaxis), STI screening, contraception, and all of the primary care things you can think of! I also am credentialed with the American Academy of HIV Medicine and can treat and manage HIVpositive patients.

I take care of children and adults, and am excited to be working in the area to provide the community with a safe space to receive their healthcare!



Meet Dr. Elizabeth King

I am a family physician/MD and have been with Aurora for the last 5 years but previously practiced in Iowa, San Francisco, and Illinois. I became involved with LGBTQ+ health in my residency and the University of Iowa and have continued ever since.

I provide gender-affirming hormone therapy with informed consent, PrEP, contraception, Pap smears, STI screening, initial treatment for depression and anxiety, and refer folks for gender-affirming surgery. We also focus on preventive care including screening labs, vaccines, and cancer screening (mammograms, colon cancer screening, etc).

I see both children and adults and truly enjoy caring for families of all kinds (chosen and biological). I am kink aware/friendly.

Named after Patton Law's own staff member Avery Abbot (right) it is one way the firm's founder, David Patton has chosen to support the LGBTQ+ community and civil rights cases.

"The Avery Project hopes to build an accessible bridge for trans and nonbinary folks to access resources to assist with the arduous process of a legal name change. For many, this can be just the first step to validating a lifelong struggle with their authentic selves. It gives them the ability to have their true selves recognized legally, which is a small comfort that has a massive reach." says Abbott.

The firm provides criminal law and



public defender services to Kenosha and Racine County residents as well as legal services in civil rights, family law, custody, juvenile justice, and adoption cases with expertise in the LGBTQ+ community.
